

**Minutes of the meeting of Seaton Ross Parish Council held on**

**Friday 7 February 2020**

A Parish Council meeting was held in the village hall on Friday 7 February 2020 at 7.30pm.

**Members present:** J Henley (Chair), R Underwood, C Hunt, D Gascoyne, C Curran and K Wealleans.

**Apologies** – P Johnson, G Gardham, and R Chapman.

**Members of the public** – 1 for item 89/90.

**89/19 Village website** – the website administrator gave the parish council an update. New comments and suggestions from the parish council were invited. It was suggested selected events from neighbouring villages could be publicised.

**90/19 Declarations of interest** – None.

**91/19 Minutes – Agreed** – that the minutes of the meeting held on 6 December 2019 be approved as a correct record and signed by the Chairman.

**92/19 Hagg Bridge closure** – ERYC had informed parishes that the closure to Hagg Bridge was due to take place from April 2020 for around seven months. ERYC would circulate further information on diversion routes for cars and buses once the exact dates were known.

**93/19 Rolawn Ltd, The Airfield – Consultation on addition to existing licence to keep 20 vehicles and 40 trailers at the premises** – the operating centre licence had been approved with one condition that vehicles must turn right out of Rolawn between the hours of 11pm and 6am.

**Agreed that the Clerk:**

- a) write to Rolawn to say it had concerns about noise pollution from vehicles loading during unsociable hours; and
- b) contact ERYC to request a blue road sign stating ‘Not suitable for HGVs’ to be positioned on Mill Lane by the village sign.

**94/19 Village sign planters** – Rolawn had kindly agreed to provide the soil for the three planters. It was decided there would be a red, white and blue colour theme for this summer.

**97/20 VE Day** – Plans for VE day were discussed. It was suggested that any event centred on the village pub. An open meeting at the pub would be organised to coordinate the different events.
