

Minutes of the meeting of Seaton Ross Parish Council
held on Tuesday 8 December 2020

A Parish Council meeting was held remotely on Tuesday 8 December 2020 at 7.30pm.

77/20 Declarations of interest – Cllr Hunt declared a pecuniary interest in Minute 87/20(a) in so far as she was the owner of The Jungle.

78/20 Minutes – Agreed – that the minutes of the meeting held on 3 November 2020 be approved and signed by the Chairman.

79/20 Parish Council Annual Accounts - current account £5,5580.62; savings account £2,481.98 – **Noted. Agreed that Cllr Chapman contact Seaton Ross Playing Field Association to see if it would like to submit a grant application.**

80/20 Payments for approval – None.

81/20 Parish Precept – The current precept was £4512.00. **Agreed that the precept remain at the same level with no increase for 2021/22.**

82/80 Councillor vacancy for co-option – **Agreed that the vacancy would be readvertised in the new year.**

83/20 Mandate for online parish council bank account – **Approved that the Clerk be given permission to set up an online parish council account.**

84/20 State of the footpaths at the south end of the village – East Riding (ER) Highways Service had inspected the footpaths and three sections of path had been identified for immediate repairs, including two tree roots. The full resurface works would hopefully take place next year to address the other less urgent issues.

85/20 Hagg Bridge Update – the bridge would now reopen in February 2021 following issues with the concrete used by the contractor.

86/20 Covid19 Response – ER had sent postcards and posters publicising the ER helplines. The Clerk had put these in the phone box and also on the noticeboard. ER Food Poverty Alliance had asked if Seaton Ross would store 10 boxes of non-perishable goods. Cllr Henley would check the village hall was prepared to store the boxes and let councillors know.
